6/5/20 Follow Up of COVID-19 swabs obtained this week noted 4 swabs were completed - of those - 1 resident was negative and 3 residents were positive. The units affected are A Hall and C Hall of Poplar Run skilled facility. Today the Team from the PA Department of Health COVID-19 Support assisted and completed swabbing of all residents and staff at the PR skilled unit. This testing will provide valuable insight into any additional resident who may have been exposed to COVID-19 but are not presenting with symptoms. We anticipate test result to start coming back to the facility Late Sunday or Monday. At that time the facility will be contacting all resident representatives to inform them of the test outcome.

Based on the test outcome - positive or negative - the facility team will have recommendations to discuss with resident representatives, which may include moving their loved one to a different room or unit to insure their safety and/or for the safety of others. While we acknowledge the importance of continuity of care and minimizing change in a residents environment, we also know that safety is of the upmost importance when it comes to the health of our residents and staff. Pending tests by unit, resident number and staff will be reported 6/6/20 once testing is completed later today.

6/6/20 StoneRidge Poplar Run has noted the onset of residents with respiratory symptoms in the personal care facility. At present four residents were tested, one test result was positive for COVID 19, the other tests are pending. The resident with the positive test was transferred to the Towne Centre skilled facility Healthcare 3 COVID-19 cohort unit. All other residents in personal care are asymptomatic. The facility has contacted all resident representatives for any resident affected and will continue to update individuals with any changing activity.

6/6/20 COVID-19 swab testing was completed yesterday for residents and staff. The number of tests by unit are reflective in the graph noted. In total 47 resident tests were completed and 50 staff tests. Results are anticipated to be returned early this week - the facility will contact responsible parties upon receipt of the testing. 6/6/20 StoneRidge Poplar Run submitted a formal request for State support with COVID-19 testing for residents and staff at the Poplar Run personal care facility this past Friday. Additionally, the corporation is working with an external agency to support mass testing (point prevalence survey) in the event the State is not able to assist. The facility plans to begin testing all residents and staff for personal care mid to late this week regardless of State support. Facility staff will be contacting resident representatives early this week to review and obtain verbal consent for testing.
