



## Independent Living Vista Restaurant Reopening Plan

**Dining Room Hours:** 11:30 AM to 2:00 PM  
4:00 PM to 6:00 PM

Reservations **are required at this time** to assist in the transition of the new dining process.

- Please do not arrive more than 10 minutes prior to your reservation.
- 2. Placemats will be disposable, allowing for one-time use;
- 3. Tables will not be preset with silverware, glasses or placements eliminating risk of environmental contaminants;
- 4. Reusable cloth napkins will not be utilized at this time;
- 5. Reusable centerpieces will not be utilized at this time on the tables;
- 6. Multi-use table condiments will not be utilized, replaced with condiments in portion cups or single use packets;
- 7. Outdoor seating will be available, weather permitting upon request at the time of the reservation;
- 8. All residents are required to **wear a mask upon entering, exiting or traveling through the dining room** but can be removed when seated for the meal when eating or drinking;
- 9. Tables will be separated by at least 6 feet for social distancing (not including space taken up by seated guests);
- 10. Residents who do not reside in the same household will be permitted to dine with other independent living residents if this dining preference is desired and customary for the residents at the table.
  - a. *To reduce the risk of COVID-19 residents will not be permitted to frequently change tablemates (Example of a dining preference not permitted – (Resident A) eats lunch with (Resident B) who lives in another household. At supper (Resident A) then wants to eat with a different resident (Resident C, etc.)*
  - b. *Tablemates are limited to only one additional household at a table –*
    - **Example 1:** *Two residents from different households want to dine together at one table – this is permitted. In this instance, the two residents at the table do not need to be separated by 6 feet at that table.*

- **Example 2:** *Four residents from different households what to dine together at one table – this is NOT permitted.*

c. *Residents visiting other residents table to table when in the dining room is considered prohibited behavior.*

11. Disposal menus will be provided and discarded after each use;
12. To prevent the risk of cross-contamination, servers will wait until the end of the meal to clear dishes. Servers will wear gloves and a disposable apron when clearing tables.
13. All occupants in the dining room are required to follow the PA Department of Health Social Distancing and Other Requirements outlined at the following web address:

  - Cover coughs or sneezes with a sleeve or elbow, not hands; Do not shake hands;
  - Wash hands with soap and water for at least 20 seconds as frequently as possible, or use hand sanitizer if soap and water are not available;
  - Regularly clean high-contact surface areas; and Maintain a distance of at least six feet from other individuals;
  - When sick, stay at home.
14. Individuals experiencing fever, cough, shortness of breath or difficulty breathing, diarrhea, chills, repeated shaking with chills, muscle pain, headache, sore throat or new loss of taste or smell should refrain from coming to the dining room and contact your physician for further assessment and recommendations.
  - a. Individuals experiencing any of the above symptoms should not return to the dining room for meals until medically cleared by your physician.
