Grateful to Givers

Thank you to church members for faithful gifts to bless the residents of our communities.

In 2020, 14 **Churches of God** (plus Women's Ministries and the Adult Fellowship) made 43 gifts totaling \$12,316—for the Forever Caring Fund and for the Church of God Home Fund.

In 2020, 68 **Evangelical Congregational churches** made 77 gifts totaling \$11,760—for the Benevolent Care Fund and for the General Fund.

# Linda Glenn



Ducks, Dogs, & Decorations



Linda Glenn says she enjoys coming to work at Church of God Home every day. She considers it her second home and her goal each day is to make people happy. She loves getting to know the residents and their families.

Linda began working at Church of God Home in 2013 in the laundry department. Five years later, she offered to be a housekeeper in Independent Living when temporary help was needed. She's been serving as a housekeeper ever since that time (and she helps in other levels of care and in the laundry department when needed).

In 2020 when families could not visit residents due to COVID-19 restrictions, Linda would assist with things residents needed – from picking up milk to helping to change a bandage. Dee Ann Garrison moved to Church of God Home in March of 2020 (right before the COVID lockdown and soon after the death of her beloved husband, Randy). Dee Ann explains that Linda says she considers the residents like her aunts and uncles. "She treats us that way and would do anything in her power to help."

Linda brings her dogs, Sassy and Molly, to visit residents on some of her days off. At Church of God Home, there are ducks that lay their eggs near the buildings. When one duck was on her nest outside of the Hobby Hut room, Linda brought duck food and provided a protective screen for the duck. Everyone was thrilled when the ducklings hatched and followed their mom to LeTort creek at the back of the Church of God Home property.

In early 2021, Linda suggested to residents that they decorate the Christmas tree for holidays – as a way to bring cheer after a difficult year. Residents and Linda donate items and funds (to purchase decorations at the Dollar Store). So far, the tree has been decked out for Valentine's Day, St. Patrick's Day, and Easter. For Mother's Day, the tree features flowers, scarves, jewelry, aprons, cookie cutters, and more.

Ella Bennethum has served Poplar Run independent living residents for 31 years and Teri Bixler has served for 19 years. Teri and Ella take care of the "front of the house" (waitstaff/servers) and Executive Chef/ Manager, Nate Schumacher, is in charge of the "back of the house" (food and kitchen staff).

Everything changed in March 2020 at the start of the pandemic when Vistas dining was closed and service as usual came to a sudden halt. Initially, the staff thought that the "lockdown" would last for two weeks.

Ella explains that the front and back of the house worked together to deliver daily meals to independent living residents. She and Teri agree that Nate was a strong leader as a system was developed to manage pick-up and delivery service for 160+ cottage and apartment residents. Nate continually kept the team updated on all COVID-related protocols.

Waitstaff called residents every day for their meal order. The team always tried to stay up-beat when calling as they could hear discouragement in some voices as time went by. Like all StoneRidge staff, team members were dealing with personal and family concerns related to the pandemic while wanting to remain positive for the residents and sensitive to their needs.

A production line of cooks filling entrée orders and waitstaff gathering sides, packaging bags, and delivering meals became the temporary new normal. Two weeks turned into five months. When Vistas dining room finally reopened in August of 2020, there were new protocols due to COVID-19 precautions. For Ella, the most difficult change has been having to wait until the end of the meal service to clear tables and not being allowed to clear between courses. Ella explains that some of the staff are new and working as servers for the first time. They will need to be retrained on the five-star serving expectations when regular service resumes. Wearing masks and face shields is also challenging and frustrating, but it's what the team has to do.

For senior living communities across the U.S. (as for employers in other fields), there are staff shortages for dining, housekeeping, nursing, etc. This led to concern when Teri, Ella, and another waitstaff had to quarantine for 14 days in October because they had contact with a resident who tested positive for COVID-19.

Ella feels that God provided an unexpected but much needed rest in October. Teri and Ella are grateful that everyone is okay and for how the kitchen staff came to the rescue of the very limited remaining waitstaff to transition back to meal delivery for two weeks while three team members quarantined.

Teri and Ella say the thing they like most about their work is the friendships they enjoy with residents and staff. They become like family. Teri shares that she looks forward to seeing smiling faces (when mask wearing is no longer required) and to giving hugs.

Poplar Run and StoneRidge are thankful for the partnership they've had with Sodexo for many years – to provide food service to residents.


"Many of my cherished memories from childhood are from traveling to Lebanon County to spend a few weeks with my aunt and uncle in the summer."


